	The April minutes were agreed to be a true and accurate record.
	Declaration of Personal / Pecuniary Interest
	Cllrs Pearson and Knowles declared an interest in discussions around the planning application for Old Hall Farm and took no part in deliberations.
	Adjournment of meeting for public comments and concerns
	Parishioners' Concerns <ul style="list-style-type: none">▪ A request was made to defer cutting the greens and verges by one month at the start of the season next year. This would allow bees to use the dandelions as a source of nectar until other sources come into flower. Views of the community on this issue will be taken into consideration.
	County Councillor Reports (as of 15 May 2021) <ul style="list-style-type: none">▪ We moved to the third stage of the roll out took place on 17 May 2021, with further easing of restrictions.▪ Regular twice weekly, home testing is being promoted, particularly for those working with others.▪ There are concerns around the Indian variant of CV-19, which is on the borders of Staffordshire.▪ SCC is developing a Local Cycling and Walking Infrastructure Plan. Meetings are being scheduled to link Bagnall's footpaths with those of other areas.

	<p>SMDC Planning Decisions</p> <ul style="list-style-type: none"> ▪ DET/2021/0012 – Lower Greenfield Farm, Jack Hayes Lane, Armshead Proposed new portal framed fodder and machinery store <p><i>Bagnall PC – made no comments as this is an application under agricultural delegated powers. SMDC granted permission</i></p> <ul style="list-style-type: none"> ▪ SMD/2020/0153 – Manor House Farm, The Village, Bagnall Construction of agricultural workers dwelling <p><i>Bagnall PC had no objection. SMDC approved.</i></p> <ul style="list-style-type: none"> ▪ SMD/2020/0072 – Old Hall Farm, The Green, Bagnall The proposed building would be of steel construction measuring 6.9m base, with 2.5m eaves and 20 degree pitched roof and 3.8m ridge.

Bagnall PC objected. SMDC refused permission. The proposed building was considered an inappropriate development in the green belt. An essential need for the building to be located in the open countryside had not been demonstrated for a building of the scale proposed, and insufficient information had been provided as to why the building could not be located within the residential curtilage of the dwelling nor why the existing stable building or existing detached garage could not be used.

New Applications

- SMD/2021/0285 – White Gables, Clewlovs Bank, Bagnall
Proposed single storey side extension

Bagnall PC has some reservations around this application, principally around the materials used for the roof

- SMD/2021/0289 – New House Farm, Bagnall Road, Bagnall
Proposed improvements to vehicular access

Bagnall PC had no objections, but suggested the use of a gate rather than a stile and that the access should be for personal use rather than business

- SMD/2021/0172 – Bagnall Green Farm, The Green, Bagnall
Proposed menage / exercise arena 25m x 45m

Bagnall PC had no objections in principle, although concerns were raised around the finished level/contours. A request for a condition to be placed on the application, if agreed, that it was for private not commercial use

- SMD/2020/0571 – Mistra, School Road, Bagnall
Single storey garage extension and 3x side elevation windows

Bagnall PC had no objection. SMDC approved. Taken to appeal on the approval conditions imposed
