Minutes of the Previous Annual General Meeting

The minutes of the previous annual meeting were read and accepted as a true and accurate record.

22.11 Chairman's Report

The Chairman, Cllr Les Knowles, read out his report for the year 2021/22. A copy will be published on the website.

22.12 | Finance Report

The Clerk / RFO reported that in the financial year 2021/22 the Parish Council requested a precept for the year of \pounds 9,100. This equated to a rise of \pounds 1.03 on Band D Council Tax, based on 368 households within the Parish.

During the year the Parish Council changed banks. HSBC advised that charges would be made to hold an account with them, and Cllrs felt it more prudent to hold our funds with a bank that did not charge, therefore funds were moved to NatWest plc in December 2021.

Our largest commitments for the financial year were the maintenance of the playing fields amounting to £975, maintenance of the greens totalling £2,100, and staffing costs at £1,968. The contracted Groundsman for the playing field failed to honour his contract in year, which resulted in the Parish Council having to secure alternative arrangements to bring the field back up to standard, therefore not all the budget allocated to this element were spent. During the year, a capital payment of £500 towards the purchase of the playing field was made, leaving our outstanding loan balance at £5,000. Interest on the loan for the year was £201, a considerable saving on the rent previously paid for the field.

In terms of receipts, we re-claimed VAT on invoices paid during the year totalling \pounds 134.68 and received a grant of \pounds 250 from SMDC and a donation from Western Power of \pounds 600 towards Christmas lighting. Two sums of \pounds 400 from Alliance Environmental towards the cost of maintenance of the greens/playing field were received, these equated to a payment for 2020/21 received late due to the pandemic and a payment for the year 2021/22.

On 31 March 2022 the monies held by the Parish Council amounted to \pounds 14,901.29.

Looking forward it is important that we look to securing additional funding from whatever sources we can to enable us to undertake the work within the Parish that we wish to do in the forthcoming year. Costs are rising and we are currently walking a fine line between utilising our known incoming resources and having to dip into reserves.

22.14 Review / Agreement of Governance / Policy Documents

Parish Councils have four main governance documents: Standing Orders, Financial Regulations, Scheme of Delegation and Code of Conduct. No changes to the first three policies have been made and it was agreed that these should stand.

The Code of Conduct has been revised in line with NALC recommendations. A copy was circulated prior to the meeting and ClIrs agreed to accept this updated version. A copy of the new version will be put on the website.

22.15 Attendance Report

Out of a potential 9 meetings, Cllrs Batson, Knowles and Lawley attended all meetings, Cllrs Pearson and Jackson attended 7 meetings, and Cllr Ralphs attended 7. Cllr Drakeley was co-opted onto the Parish Council in July 2021 and out of a potential 8 meetings, attended 5.

Zoom meetings were permitted by a change in the law until 7 May 2021. The Parish Council gave Cllr Ralphs dispensation from S.85 of the LGA 1972 to attend via this method until the year end.
