Minutes of the Previous Meeting

Adjournment of meeting for public comments and concerns

Parishioners' Concerns:

The owner of the land for the proposed dog exercise area requested clarification of the Parish Council's decision on their planning application. SMDC had refused permission and the Parish Council was made aware that they proposed to this decision to appeal.

County Councillor Reports

Cllr Flunder advised that a new CEO had now been appointed for the County Council.

A new approach to the DHP funding is being put in place, led by Lisa Hall. It is hopeful she will meet with Clirs in due course.

The Department of Transport has allocated £4.5 million towards highways maintenance.

SCC has put aside £10 million in its budget for highways - none of which has been

earmarked for roads anywhere in the north of the county (Bagnall).

Over the next two years £30million (£15million per annum) will be directed towards pothole repairs. Stanley Road is already on the list; Cllrs were asked to suggest other areas in the Parish that required attention.

As part of SMDC's Tourism initiative, Karen Bradley, MP is publishing information, focusing on specific areas for each edition; local pubs and attractions should contact her to promote their

business.

£410k available for small businesses to expand and to help local organisation such as the scouts.

Cllr Flunder has allocated funds for horse rider and weight restriction signage. He will send information on positioning to the Parish Council.

Cllr Flunder will chase up work on preventative measures for speeding through the village.

SMDC's Planning Decisions

SMD/2023/0055 - Greenway Cottage, Bagnall Road, Bagnall,

Lawful Development Certificate for a Proposed use of property as residential care home (Class C2) for up to 2 children aged between 5 and 18 with care provided by up to three non-resident members of staff (no material difference with lawful use as Class C3 dwelling)

Bagnall PC had no objections – SMDC Approved

New Applications

SMD2023/0019 - New House Farm, Luzlow Lane, Bagnall, Demolition of existing outbuildings and replacement agricultural building Bagnall PC had no objections

Deferred Decisions

SMD//2023/0063 - Kerry Hill Farm, Eaves Lane, Armshead

Change of use from agricultural field currently used as grazing land for horses to use as a dog exercise field. The area of development will utilised a previously fenced paddock used for grazing horses which will result in no physical changes to existing boundary hedges and fences which have been in place for agricultural purposed for the past 40 years.

Bagnall PC objected.

Application for the grant of a premises licence – Lockside, Greenway Hall Road, Stockton Brook

Bagnall PC objected – it will now go to Hearing Committee mid May early June

23.02 Finance

23.02/01 Quarter 4 Financial Report

At the end of the financial year 2022/23 the Parish Council held monies to the value of £15,263.51, comprising £4,997.83 in the current account and £10,265.68 in Earmarked Reserves. The outstanding loan on the playing field purchase is £5,000.

23.04 Footpaths and Highways

Matters arising from previous minutes.

23.04/01 Footpath 20 (The Smithy)

Cllrs Batson and Knowles will negotiate with the farmer a suitable position for a stile. Following this an application will be made to SCC for an access to the highway.

Action: Cllrs Knowles and Batson

23.04/02 Footpath 28

SCC has suggested the installation of wooden planks across the footpath to stop motorbikes, but in turn this creates a problem for wheelchair users.

It is planned that Parish councillors will oversee and work with volunteer parishioners to improve the condition of the footpath themselves. SCC Footpaths will be asked to provide the necessary stone and other materials and re-imbursment of incidental costs'

New Issues

23.04/03 BT box

The BT box on Stanley Road adjacent to the Rose and Crown has been hit and slightly damaged for a second time. The Clerk was asked to contact BT/Outreach and Highways regarding its relocation to avoid future damage. Serious damage would have a huge impact on the village's telephone and internet usage.

Action: The Clerk

23.04/04 – Tipping

Further tipping has taken place at Blue Bridge, this has been removed.

23.05 Correspondence

A canvasing leaflet has been distributed with Parish, the information it contained has upset Parish Councillors as there are claims of undertaking or being involved in works which are not correct and undermine the work of the Parish Council.

23.06 Date of next meeting
