- individual emails must be set up. Clerk discussed quotes received from Parish Online and Easywebsites. Cllr Batson asked Cllr Knowles to consider the way forward in the next 4 weeks.
- Update from Town and Parish Councils Working Group meeting - Cllr Knowles informed all that 3 Cllrs had attended various presentations on proposed devolution plans. Recommendations SMDC has put forward out of four is a North and South Staffordshire plan. Cllr Knowles explained the different areas and population sizes. Cllr Knowles is part of the Town and Parish Council working group, the purpose of this is to help Town and Parish Councils to work together better. The last meeting attended was primarily about Devolution. Cllr Knowles questioned Stoke on Trent's debt and explained that they had received a loan not a grant. Stoke on Trent City Council is 9.3 million overspent this quarter. Concerns locally about SMDC providing more housing. Chief Exec for SMDC Andrew Stokes states this is not an issue as they are going to be looking at the A50 corridor for most of the housing requirements. Cllr Knowles also states the council tax bands were a concern and was told they will be harmonised. This was confusing, concerns were that Staffordshire Moorland residents would be paying more. Cllr Knowles asked about Greenbelt and BESS sites being Greybelt, he was told that this was incorrect. He stated his concerns about Greenbelt in the Staffordshire Moorlands. Cllr Knowles asked about a resident's survey. he was told that this would be online, he suggested this was done as hard copies and again was told it was not possible. Cllr Knowles also explained how the merger with Stoke-on-Trent would work with numbers of Councillors. From the Parish Council's susceptive, we would be concerned about our assets for e.g. Bagnall playing field could become an asset of Stoke on Trent. A job for Parish Council is to preserve our assets. Cllr Batson mentioned a report from BBC stating that the costs would be huge to complete devolution. Cllr Knowles discussed a question and answers document received, see below.

Cllr Knowles to consider options for GOV.UK email address and website.



 Devolution - Cllrs Ralphs congratulated Cllr Knowles for information given about devolution. Cllrs Ralphs discussed where Devolution came from in depth and the reasons behind it. She believes that this is all about control and will result in large Unitary Authorities with

Cllrs being responsible for up to five hundred people. She believes that Parish and Town Council will go. The cost to divide the authorities will cost millions. Cllr Ralphs mentioned with the current changes in government she feels that there may be changes to come in relation to Devolution. Cllr Ralphs discussed information seen in the newspaper about crime rates in Stoke on Trent being the most dangerous place to live in the Midlands. Cllr Ralphs discussed the debt in Stoke on Trent in depth and how well budgets were managed in the Staffordshire Moorlands. Cllr Ralphs hope that people will come together and say no to Devolution. Use of Parish land for advertising - Cllr Knowles reminded all about the long-standing agreement that no one can use the village green for the purpose of advertising. A request had been received to use the village green. For a request to be granted a decision would need to be agreed by the Parish Council to allow this to happen going forward. Cllr Knowles is concerned and does not want the flood gates to be opened. Cllr Ralphs explained the reasons behind the decision originally. Cllr Knowles stated that a robust structure must be put in place and agrees that the Parish Council should support local Bagnall Community Groups. Cllr Krawiecki explained the reasons for the request and the importance of advertising to raise funds. Any future applications for advertising must go through the Clerk. Clerk to discuss with conservation. Cllr Krawiecki states that this is an exception purely for the benefit of the community and will pass the information to the Village Hall committee. Highway Routine maintenance/weedkilling and sweeping - Cllr Batson has chased with Cllr Edawards twice. Email received awaiting response from Cllr Edwards. Cllr Batson is very frustrated and does not think it is his responsibility to chase this. Cllr Batson is working on this and will be raising a complaint. Cllr Knowles discussed gritting. Cllr Batson informed Cllr Knowles that gritting is a Staffordshire County Council's responsibility. Cllr Ralphs offered to order grit for Jack Haye Lane.
